Note: In order to initially qualify for a temporary volunteer dentist's license you must currently hold an active general license to practice dentistry in a state other than Maryland that permits clinical practice and is not subject to clinical restrictions. In addition, you must have **either**: 1) Passed the **NERB** North East Regional Board Clinical Examination/**ADEX** Approved Dental Examination, **or** 2) Have, for at least 5 years preceding your application, held a general license to practice dentistry in another state that permits clinical practice, and, in that 5 year period you must have actively engaged in practicing dentistry for at least 850 hours on average per year. (A total of at least 4,250 hours). Those who do not meet these initial requirements may not be considered for a temporary volunteer dentist's license. In addition, either you or the entity that is hosting the temporary dental clinic must provide evidence to the Board that you are covered by malpractice insurance for the duration of the temporary dental clinic.
